From the desk of the Chief

It is hard to believe that school is already in session; summer seemed to fly by! This time each year, along with all the excitement of backto-school, it is a good time for both parents and students to brush up on the topic of safety. The Citrus Heights Police Department (CHPD)

would like to remind all students and parents of the shared responsibility they have in understanding and obeying traffic laws that help maintain safety in and around our

school zones. Toward that end, CHPD has put together a helpful tri-fold brochure that lists, and explains in detail, the most commonly violated traffic laws in our city's school zones. This brochure is free to anyone wishing a copy; simply contact or visit the department and ask for the School Zone Traffic Laws pamphlet.

It is also important for families to review some basic safety rules:

•Talk to your children about strangers and the importance of knowing who will be picking them up after school. They should *never* talk to strangers for any reason.

•If your children are walking or biking, have them do so with a friend and pick a safe route with high visibility. They should never take a short cut through an area with which they are unfamiliar.

- •When picking your children up from school, stop and park in designated areas.
- •Make sure your child's school has the most updated emergency contact information for you.

• If your child is walking or biking to and from school, please talk to them about the importance of being aware of what is going on around them. Texting or listening to music while walking or biking is dangerous and distracts them from their surroundings.

•Explain bicycle laws; **everyone** under the age of 18 must wear a helmet if they are riding a bicycle, skateboarding, skating, or riding a scooter.

•Write down the make, model, and serial numbers to valued property your child takes with them to school (iPod, cell phone, bicycle, etc.). Store this information in a safe place in your home; it will be useful in recovering your child's property if stolen or lost.

These reminders, as well as other important information on bullying, cyber safety, bicycle safety, calling 9 -1-1, etc. is available in printed form for parents and teachers to use and/or distribute. As well, law enforcement personnel are always happy to stop in and speak directly to our youth on the importance of personal safety and well-being.



City Hall/MOB Update

Community Gathers to Celebrate Completion of New State-of-the-Art City Hall

After just over one year of construction, the new Citrus Heights City Hall located at 6360 Fountain Square Drive officially opened to the public on August 9. On August 25, the Citrus Heights City Council and City Manager Henry Tingle (pictured right) cut the ceremonial ribbon at the City Hall Dedication Ceremony to celebrate the momentous occasion. Following the ceremony, City staff offered public tours of the new City Hall.

The City Hall project was managed by Capital Partners Development Company; designed by



Perkins, Williams, and Cotterill Architects; and constructed by Ascent Builders, Incorporated. The new City Hall consolidates 65 employees, once housed in four separate aging structures, into a single energy-efficient building with an adjacent 4,000-square foot utility building. The new City Hall houses a "one-stop" public counter to provide convenient access to City services. Additional features include a stunning fountain, art displays, community meeting spaces, and drought-tolerant



landscaping.

In March 2015, the City Council unanimously approved the Medical Office Building and City Hall Project – a unique public-private-partnership that will result in a direct investment of \$53.2 million into the Citrus Heights economy and generate more than 170 jobs. The project includes the demolition of the former City Hall; construction of a new City Hall; and the development of a Medical Office Building. AMPCO Contracting,

Incorporated completed demolition of the former City Hall Complex at the corner of Greenback Lane and Fountain Square Drive in fall 2015.

Dignity Health Prepares to Break Ground on Medical Office Building

Dignity Health is expected to begin construction on a new 68,000 square-foot Medical Office Building at the corner of Greenback Lane and Fountain Square Drive fall 2016. The three-story Medical Office Building will be operated by Dignity Health Medical Group and provide primary and specialty care services to the local community.

Back to School Safety Tips

It's that time of year again. Summer is coming to a close and kids are headed back to school. Remember to safely share the roads with school buses, pedestrians and bicyclists, and provide children with the necessary knowledge to stay safe at school.



As motorists, remember that there will be increased traffic at drop off and pick up times. There will be an increase in pedestrian and bike traffic as well. It is important to drive slowly and cautiously around these areas and be alert! According to the National Safety Council, more children are hit by cars near school than any other location.

WALK Madd

A few precautions go a long way toward keeping children safe. As a driver:

- Don't block the crosswalk when stopped at a red light or waiting to make a turn, forcing pedestrians to go around you; this could put them in the path of moving traffic
- In a school zone when flashers are blinking, stop and yield to pedestrians crossing the crosswalk or intersection
- Always stop for a school patrol officer or crossing guard holding up a stop sign
- Take extra care to look out for children in school zones, near playgrounds and parks, and in all residential areas
- Don't honk or rev your engine to scare a pedestrian, even if you have the right of way
- Never pass a vehicle stopped for pedestrians
- Always use extreme caution to avoid striking pedestrians wherever they may be, no matter who has the right of way

It's never more important for drivers to slow down and pay attention than when kids are present – especially before and after school. By exercising a little extra care and caution, drivers and pedestrians can co-exist safely in school zones.

Autumn is Coming

As we move into the autumn months, the leaves will begin to fall off the trees, potentially clogging our storm drain system. This can lead to street flooding or even flooding of homes. The City of Citrus Heights has street sweepers come through twice a month to help collect street debris and prevent clogging of the storm drains.

Here are a few tips to help get the most from our street sweeping work:

- DON'T rake leaves into piles in the street piles can clog gutters and drains, and may
 result in flooding during heavy rains. Piles also become road hazards and cannot be
 swept by the street sweeper.
- DO use your green waste or composting containers for leaf recycling.
- DO keep lawns, driveways, streets and sidewalks clear of leaves.
- DO keep trees and shrubs trimmed so that they do not obstruct the sweeper.
- DO keep basketball hoops out of the street and gutters.

Foster Fortunes

Thank you, Citrus Heights City staff for stepping up time and time again to help foster kittens, puppies, reptiles, birds and senior pets for the Animal Services division! The best part is that these animals are able to find homes through the fostering process, in addition to saving our taxpayers' money! Recently, five (5) Chihuahua mix puppies were fostered by City staff – and have now found Furrever homes!

Since 2010, Citrus Heights Animal Services and its partners have reduced animal intake numbers from 1250 in 2010 to 759 in 2015. Between September 2013 and February 2016, the City, with the help of local rescues, veterinarians and helpful citizens, has spayed and neutered over 2200 cats, preventing unwanted litters of kittens and reducing countless cats going to the shelter!

Let's continue to aim for ZERO stray/abandoned animal intakes! Keep pets out of shelters by spaying or neutering, licensing and micro-chipping... And by becoming a foster family! Planning Division

The Planning Division coordinates the City's review of residential and commercial development projects. The Planning Division evaluates the project for compliance with the City's General Plan, Zoning Code, and other City Standards. Below is a selected list of projects currently under review:

- 7625 Antelope Road Mariposa Creek Subdivision. Proposed new subdivision of 15 single-family homes.
- 7807 Madison Ave Fine Wine and Spirits. Proposal to add distilled spirits and extend the hours of operation for an existing business.
- 7534 Old Auburn Road Bearpaw Village. Review for the development of a 43unit townhome project.
- 7601 Sunrise Boulevard Human Bean. Application has been received to construct a drive-thru coffee kiosk on a vacant parcel just north of Old Auburn Road and Sunrise Boulevard.

Hen Keeping. The City Council approved the revisions to the City's Animal Keeping regulations that will allow the keeping of hens on all single-family property sites, regardless of lot size. The City's Zoning Code previously only permitted chickens on residential lots 10,000 square feet or larger which are mainly found in more rural areas of the City. The regulations require that hens must be contained from sunset to sunrise as well as provide requirements as to where a coop may be placed. Note: this does not change the existing regulations on the keeping of roosters. Roosters are only permitted on within the RD-1 or RD-2 zoning district or on residential lots of 20,000 sf and larger. The area groups usually meet once a month to solve neighborhood issues such as traffic or crime, to work on various projects, to host City information sessions, to network, have fun and much more.



Citrus Heights First-Time Homebuyer Program

Need Help Purchasing a Home? THE CITY CAN HELP!

The City's First-Time Homebuyer program provides low-interest loans of up to \$40,000 to low-income homebuyers that may be used for a down payment and closing costs.

Low-Interest Loans

The low-interest loan is structured as a second mortgage. The loan will have a rate of 3.00%, a term of 30 years with no required monthly payments. The total sum of the loan, with interest, will be due at the end of the 30-year term, upon sale or transfer of the property or if the borrower no longer occupies the home as their primary residence. The borrower must contribute a minimum of 1.00% of the purchase price. The actual amount of assistance is based on financial capacity.

Eligibility Requirements

- The applicant <u>must not</u> have owned a home as a principal place of residence within the past (3) complete years.
