From the Desk of the Chief



On April 9, 2014 at approximately 4:00 p.m., Citrus Heights Police Officers conducted a car stop on Oak Avenue of a vehicle driven by Jeremy Zahn, a known subject on Post-Release Community Supervision (PRCS). Mr. Zahn had been under investigation for approximately four weeks by the newly formed Citrus Heights Police Department's (CHPD) Special Investigation Unit (SIU) / PRCS Enforcement Team.

During that traffic stop, detectives located approximately 48 pounds of vacuum sealed, processed marijuana – packaged for sales – in boxes on the back seat of Zahn's vehicle. Zahn was arrested for transportation of marijuana, possession of marijuana for sales, and violation of his PRCS conditions; he was booked at Sacramento County Jail.

Next, a search warrant was obtained for a residence in El Dorado Hills identified during the investigation as being associated with Zahn. A search of that residence resulted in the discovery of an additional 810 pounds of processed marijuana, much of which was concealed behind a false wall. Two large safes, located in the garage, contained over \$460,000 in U.S. currency, additional marijuana, seven firearms, ammunition, and high capacity magazines. The firearms consisted of illegal assault rifles, semi-automatic handguns, and a semi-automatic rifle; three of the firearms were identified as being stolen. Total weight of the seized marijuana was 858 pounds bearing a street value of approximately \$2.5 million dollars.

This investigation is on-going and was initiated by CHPD's SIU/PRCS Team. My vision when creating this team was one incorporating inter-agency cooperation, regionalization, and collaboration in response to the effects of prison realignment on our communities. The unit is just that: a regional team consisting of a CHPD sergeant and detectives, a detective from the Folsom Police Department, and a full-time, assigned Probation Officer from the Sacramento County Probation Department. The mission of the team is to monitor Post-Release Community Supervision offenders and, as you can see, the work they are doing (right out of the gate) is impressive – this particular case is one of the most significant of its kind in our region. We look forward to more of the same going forward; unfortunately, there's much to do. The good news: this dynamic partnership is way out in front of the problem having already shut down a major drug trafficking operation.

CHPD is assisted in this continuing investigation by the United States Department of Justice Bureau of Alcohol, Tobacco, Firearms, and Explosives, and the Federal Bureau of Investigations. Auburn Blvd Complete Streets Improvement Project Update

The Auburn Boulevard Complete Streets Improvement Project is inching closer to completion. Road reconstruction has been completed in stages in order to maintain pedestrian access in the construction zone at all times. With each stage the contractor is demolishing the existing sidewalk and driveways and installing new sidewalks, driveways and curb and gutter. Once the road reconstruction is complete, other subcontractors are following behind, erecting the new street lights and installing the irrigation lines and new landscaping. Road reconstruction on the east-side of Auburn Boulevard from Sylvan Corners to Pratt Avenue is almost complete and the contractor is currently demoing the last stage from Pratt Avenue to Kanai Avenue (west-side). Segment III is still on schedule to be completed in Summer 2014.

The City is also planning a ribbon-cutting ceremony this summer to celebrate the opening of the new Auburn Boulevard. Stay tuned for more information on that event!



Did You Know that Used Motor Oil Never Wears Out?

It just gets dirty. But oil can be recycled, cleaned, and used again. Recycling used motor oil conserves a natural resource (oil) and is good for the environment. Motor oil poured onto the ground or into storm drains, or tossed into trash cans (even in a sealed container) can contaminate and pollute the soil, groundwater, streams, and rivers (and it's illegal!). Recycling your used motor oil reduces this pollution threat. When you take your used oil to a certified center for recycling, you are protecting the environment, conserving a valuable resource, and getting paid for it! Please recycle your used motor oil.

Used motor oil can be placed in a jug and sealed and then put on the curb next to your recycling cart on recycling week. Used oil filters can also be recycled, drain the used oil filter of any oil and place it in a sealable plastic bag, such as a Ziploc bag. The sealed bag with the filter can then be placed or taped to your used oil jug. Don't have a jug? Contact Republic Services at (916) 725-9060 and they will deliver one out to you! Be Prepared - Family Disaster Plan

Oftentimes when there has been an upsurge of disturbing news stories, the police department is flooded with calls about how citizens can prepare themselves and their families for emergencies. We recommend that they train and prepare their families, and have a plan in advance that they have discussed and practiced.

Having a Family Disaster Plan does not have to be complicated. There are some easy to fill out templates available on the [American Red Cross website](#) and other reputable government sources. One of the things that we recommend is to have an "Emergency Binder" put together prior to any emergency.

This binder should include the names, birthdates, and contact information for all of your family members. There should be your emergency contacts, and any medications that are required by your family listed. Then discuss with your family where your meeting place would be in case there was a major emergency and all of you were away from home, and cell services were down. It can be a relative's house the next town over, or a public area such as your local church or school.

Discuss with your children what the most likely disasters could affect your household, be it fire, earthquake, or flood. Talk about escape routes from your home to your designated safe meeting place. If your family is separated during the emergency, where will the meeting place be for you?

Talking to children about disasters or emergencies does not have to be something that frightens them. You can make practicing evacuating your home an age appropriate game, seeing who can get to the meeting place first, et cetera.

Share your completed plan with those who need to know it. This could include extended family or friends. Check in with your family every 6 months or so to review or update your plan as needed. Assure your family that the more prepared they are for the unknown, the less power the unknown has.

There are several emergency food kits available for purchase at major retailers, and plenty of websites that show how to assemble one. Don't overlook the need to store enough water. Per [FEMA](#), a good rule of thumb is:

- ♦ One gallon of water per person per day, for drinking and sanitation.
- ♦ Children, nursing mothers and sick people may need more water.
- ♦ A medical emergency might require additional water.
- ♦ If you live in a warm weather climate more water may be necessary. In very hot temperatures, water needs can double.
- ♦ Keep at least a three-day supply of water per person.



Citrus Heights offers Free Sterilizations for Feral Felines & Owned Cats

Thanks to a grant from PetSmart Charities®, the City of Citrus Heights Animal Services (CHAS) has been able to initiate a pilot program, partnering with Sacramento Area Animal Coalition (SAAC) and River City Cat Rescue, (RCCR), two local non-profit agencies, to provide vouchers for free spay or neuter for feral cats for humane feral population management. All feral felines will have the tip of their ear removed while under general anesthesia and receive a rabies vaccination during their spay/neuter surgery to indicate they have been sterilized.

Additionally, CHAS will offer free spay/neuter vouchers to cat owners in the 95610 and 95621 zip codes to prevent the birth of unwanted kittens, reducing their numbers at shelter and their likely euthanasia.

The pilot program offers three options for sterilizing cats:

Sacramento Area Animal Coalition (apply online at www.sacanimal.org)

Feral cat voucher

Owned cat voucher

River City Cat Rescue (email info@rivercitycatrescue.org to request a feral or owned cat voucher.)

CHAS – To receive more information sterilizing stray & feral cat colonies in your Citrus Heights neighborhood, contact CHAS at 916-725-7387. Our Animal Services Officers will be happy to assist you in ascertaining the nature of the population and whether the cats are eligible under the program.

The City of Citrus Heights relies on grant funding and donations to offer free and/or low- cost sterilization & vaccination services for pet owners in the community. For more information or to find out how you can help, please call 916-725-7387.



Continuum of Care Advisory Board

The Continuum of Care Advisory Board provides guidance regarding services to the homeless and emergency sheltering in Sacramento County.

The Advisory Board met on April 9, 2014. Ryan Loofburrow was welcomed as the new Executive Director of Sacramento Steps Forward (SSF), starting on March 17, 2014. He previously worked for the Downtown Sacramento Partnership as the Director of Community Services and most recently served as the Executive Director of the Downtown San Diego Partnership's Clean and Safe Program.

Winter Sanctuary

This interfaith rotating shelter program closed March 31 having served an estimated 500 individuals. SSF has received positive responses from participating congregations.





Road Construction Projects



Project	Status
Auburn Boulevard Segment 3	Working on the east & west side of the street. Completion of the project is June 2014.
Advanced Traffic Management System (ATMS)	Work on Antelope & Kanai is scheduled for the next three weeks, new signal poles and trenching for conduits being the main part of the work. The traffic movement at the intersection will get worse when the pavement trenching is being accomplished, but new detection for vehicles and bicycles will be part of the new work. In other areas of the City (mainly the Auburn corridor from Van Maren to Sylvan Road) equipment failures have slowed the connection and interconnection for these intersections. This means signalized intersections will continue to operate in the same manner for now. Programming to synchronize this corridor will wait for new communications improvements.
Area 5 Traffic Safety, Accessibility and Walkability Phase 1B Project	Bids for the work were opened on April 3rd and staff received City Council approval of the construction contract on April 24th. Construction should begin around mid-May 2014.
Sunrise/Sungarden Intersection Safety Improvement Project	The project design is complete. Staff plans to submit a Request for Authorization (RFA) to construct to Caltrans in April and anticipates advertising for construction bids in June (pending Caltrans approval of the RFA).
Sunrise Blvd Complete Streets Improvements - Phase 3 (Antelope Road to north City Limits - west side only)	The City's Right-of-Way acquisition team continues to meet with property owners, from whom right-of-way is needed, to review the offer packages sent out in March. The design consultant submitted the 90% plan and estimate package for City review in April.
Areas 8, 9 & 10 Drainage Master Plan Study	This project is ready for presentation to Areas 8, 9 and 10 residents for a final review. The input from residents at this meeting will be incorporated into the final document.
SRCC Creek Cleaning	Crews removed 14 bags of litter, 16 yards of material from creeks and 8,000lb of weeds along Cripple Creek at Auburn, Misty Creek at Van Maren, Bridgemont at Van Maren and San Juan at Spicer.
2014 Residential Street Resurfacing Program	Staff completed field reviews and 65% plans and estimates in March. The utility notification letter will be issued in early April. Staff expects to advertise for bids in late May and begin construction in early July 2014.
Storm Drain System Yearly Cleaning	The annual storm drain cleaning is complete. Through the end of this fiscal year, staff will continue to address complaints related to clogged storm drains as they come up. Next fiscal year, the yearly cleaning will focus on Neighborhood Areas 6, 7, 8 and 9.
Sunrise Blvd Bus Stop Improvements Project, Phase 2	This project was awarded to Central Valley Engineering and Asphalt, Inc. at the April 10th City Council meeting. Construction began at the end of April 2014.
Twin Oaks and Mariposa Diversion Pipe (Area 6&7 Master Plan Implementation)	Staff and environmental consultants had a field meeting with the Department of Fish and Wildlife and the Army Corps of Engineers on April 30th. The results of this meeting will establish the environmental document necessary to complete design of this project.
City Hall Green Parking Lot	Construction bids for this project were opened on April 17th. J.D. Pasquetti Engineering was awarded the contract at the April 24th City Council meeting, and construction is expected to start by mid-May.
Baird Way Drainage Improvement Project	The Baird Way and Canyon Oaks projects are tracking on the same schedule at this time. An assessment of the existing storm drain system is underway. The results of the assessment will help determine a design that will resolve the drainage issues in this area.




