From the desk of the Chief



Partnerships afford people/entities the opportunity to accomplish more by working together than they otherwise could alone; and do so more efficiently, effectively and

with far broader strokes. To this end, the Citrus Heights Police Department (CHPD) is actively involved in many community-based, successful partnerships, focused on improving the quality of life enjoyed by our citizens. These partnerships help build and strengthen relationships between law enforcement and the community, enhancing the safety and well-being of all.

Some of the partnerships forged by CHPD, and in which we take a lead role, include our Citizens' Academy, the Citrus Heights Police Activities League (CHPAL), our Domestic Violence Response Team (DVRT), the Citrus Heights and Multi-Housing Partnership (CHAMP), our Volunteer and Explorer programs, and the Holiday Referral Program. The department also plays a considerable role working diligently with all 11 Neighborhood Association (NA) groups within our City. Other successful, local collaborations in which CHPD participates include the Domestic Violence Intervention Center (DVIC), Residents' Empowerment Association of Citrus Heights (REACH), Citrus Heights Collaborative, Leadership Citrus Heights, Citrus Heights Youth Summit, and the Citrus Heights Regional Chamber of Commerce. We also work closely with our local service groups such as Rotary, Kiwanis, Soroptimists, and the Citrus Heights Women's Club.

Additionally, CHPD has taken the lead in initiating a regional approach to addressing issues facing law enforcement due to current economic conditions and shrinking budgets. Joining forces with neighboring police departments to bundle purchases of new equipment and technology realizes substantial savings for all participants. Inter-agency group training is also cost effective and is being utilized for technology, as well as K9, SWAT and motor teams. As well, once a month, traffic units from multiple agencies gather in one city and work together; they also join forces to host DUI checkpoints. These regional traffic enforcement efforts demonstrate that the safety and well-being of all our citizens is a universal priority. Spay Day 2015 Appointment Request

Spay Day takes place on Sunday, March 1, at veterinary clinics and animal shelters in Sacramento and Yolo Counties. Applications began being accepted on Saturday, January 17, 2015. Some appointments will be available February 16 through March

12. Appointment scheduling will begin on February 2, 2015 once an application has been received. **Spay Day Eligibility Guidelines**

- Open to residents of Sacramento County and Yolo Counties only
- Must receive public assistance and/or have an annual household income of \$35,000 or less
- Proof of income is required
- Cash payment of \$15 per cat and \$20 per dog is required at time of appointment
- Limit two pets per household

Citrus Heights residents may still apply for feral cat vouchers.

Licensing FAQ

How many pets are residents of Citrus Heights & Sacramento County allowed to have? Residents may have up to 4 dogs AND 4 cats in the same household.

What do I need to do to license my pet? Pet owners should be sure their animal is up to date on their rabies vaccination and provide a copy of the rabies certificate at the time of licensing.

Do cats really need to be licensed, too? Yes, they do. In addition, we recommend Microchipping since cats often lose their collars. Licensing and Microchipping helps both dogs and cats get home!

Why does my pet need a rabies vaccination? The Center for Disease Control (CDC) requires all domestic mammals be vaccinated for rabies. The CDC mandates that states and counties track rabies cases. Licensing helps track proper rabies control in the county ensuring human safety.

How much does it cost? Is your pet fixed? Fixed animals (spayed or neutered) rates are \$15.00 per year and requires a proof of spay or neuter be provided at the time of purchase. Citrus Heights residents pay \$30.00 per year for unaltered animals. Licenses must be renewed annually.

The Little Free Libraries will soon be installed in the Citrus Heights area, Mang is currently working with City staff in staking out approved sites for placement.

Auburn Phase II (Rusch Park to the Northern City Limits)	City Council awarded a design services contract to Parsons Brinckerhoff on December 11 th . Staff is seeking Caltrans approval of the contract.	
2014 Residential Street Resurfacing Program	Central Valley Engineering and Asphalt (CVE) is substantially complete on the project. Staff and CVE will conduct a final "punch list" walk. Final acceptance of the project is anticipated in February.

CHPD Traffic Team

The Citrus Heights Police Department's Traffic Unit has 1 sergeant and 7 full-time traffic officers. The goal of the Traffic Unit is to assist in the safe, smooth flow of traffic, and reduce collisions within our city. The traffic officers utilize community oriented policing and traffic issues are addressed with an Education-Engineering-Enforcement emphasis.

Responsibilities of the traffic unit:

- Investigation of traffic collisions
- Enforcement of traffic laws
- Red Light Photo Enforcement
- DUI enforcement
- Calls for service
- Parking issues
- Special events
- Citizen complaints or traffic concerns

If you have any questions regarding the traffic units responsibilities or traffic issues in your area, please attend your neighborhood association meeting in February. Members of the Citrus Heights Traffic Unit will be attending each of the neighborhood association meetings throughout the month.



PROPOSED MOB AND CITY HALL PROJECT UPDATE



The City is currently studying the feasibility of a proposed public -private partnership with Dignity Health and Capital Partners Development Company to construct a medical office building and new city hall. If approved, the project would include the construction of a medical office building on the current City Hall site and the development of a new city hall on the vacant property on Fountain Square Drive and Stock Ranch Road, just north of the Post Office.

As part of the review process, the City is preparing an Environment Impact Report (EIR) to analyze the potential environmental effects of the proposed Medical Office Building and City Hall Project. On December 12, 2014, the City released the Draft Environmental Impact Report (DEIR). The Planning Commission held a public hearing to receive comments regarding the DEIR on January 14, 2015. The City is currently reviewing public comments and preparing responses to include in the Final Environmental Impact Report (FEIR).


In addition to the environmental review process, the City is also evaluating the Design Review Permit Application for the proposed medical office building and new city hall. The design review process is intended to ensure the plans are consistent with the City's Design Standards. The City's Planning Commission will serve as the approving body for the Medical Office Building and City Hall Project Design Review Permit.

The Planning Commission will hold a public hearing to consider the Final EIR and Design Review Permit Application, on March 11, 2015, at 7:00 PM in the Council Chambers (7117 Greenback Lane). On March 12, 2015, City staff will present the draft leases related to the proposed Medical Office Building and City Hall Project to the City Council in a Study Session at 5:00 PM in the Council Chambers. The City Council will consider whether or not to approve the Medical Office Building and City Hall Project, including the Final EIR and leases, on March 26, 2015, at 7:00 PM in the Council Chambers.

The calendar/customer service guides provide residential customers of Republic Services with information on when to place cans out for service and general information on services. The artwork for each month showcases the winners of the 2014 Recycling Poster Contest in which amazing artists from our local Citrus Heights elementary and K-8 schools from the San Juan Unified School District participated. Congratulations to all the contest winners and thank you to all the schools that participated!

Here is a quick guide to the calendar and its contents:

- January Table of Contents
- **February** Household Hazardous Waste Drop-Off Events: The City and Republic Services hold three FREE drop-off events per year. Bring your unused household chemicals, cleaners, auto fluid, paints, solvents, acids, fluorescent lamps/tubes, and other HHW to these drop-off events.
- **March** Trim Your Waste: Want to participate for a chance to win \$100? Republic Services will randomly select a household from each Neighborhood Association area and check its Recycling Cart for its contents. If the cart has no contaminants, that household will be awarded \$100 prize!
- April Trash Service: What goes in your trash cart? See the month of April for general guidelines.
- **May** Neighborhood Clean-up (NCU): Residential customers get three bulky-item neighborhood clean-ups per year. Are you planning on doing some major spring cleaning? Or just want to get rid of some junk? See the month of May for information on what items can be set out for NCU and the size limitations of your piles.
- **June** Curbside Recycling: What can you recycle? Recycling is good for our planet! Do your part. Check the month of June to see what items are acceptable for recycling.
- July Home-Generated Sharps: Did you know that Republic Services offers FREE front-door collection of your used home-generated hypodermic needles, syringes and lancets? Just place them in an approved sharps container and contact Republic Services to set an appointment for pick up.
- August Where do your Recycled Materials Go? Do you know? Check out the month of August for fun facts and information on what happens to the items you place in your recycling bin.
- September Household Batteries, Motor Oil and Oil Filters: Did you know that residential customers can have these items picked up for FREE? See the month of September for information on how to prep your used/old household batteries, used motor oil and used oil filters so they can be recycled.

• **October** – *Green Waste Collection*: What can you place in your green waste cart? See the month of October for general guidelines.

- November *Extra Leaf Collections*: It's that time of year and leaves are falling. Sometimes you have so much that it simply cannot all fit inside your green waste cart. Did you know that Republic Services can collect up to six extra bags of green waste on your collection day during the months of November through January? Simply call to notify Republic of the extra bags. The first two bags are FREE and it is only \$5.66 for every additional two bags.

Curbside Collection:

* These items are not accepted at the HHW drop-off events but can be recycled and/or properly disposed of by residents through our curbside collection and at-door collection services provided by Republic Services.



Recycle Used Oil and Oil Filters! Motor oil doesn't wear out, it just gets dirty. Here's how you can recycle it:



Drain It: Pour used motor oil in a jug. Used oil filters can also be recycled but first must be drained of any remaining oil.

Zip it and Seal it: Place the used oil filter into a sealable plastic bag, such as a Ziploc bag. Seal the jug of used motor oil shut so it cannot spill.

Tape it up and Set it out: Tape the Ziploc bag with the oil filter in it to the used oil jug. Set the sealed jug of used motor oil out on the curb next to your recycling cart on recycling day. Republic Services will pick it up and recycle it, free of charge. Don't have a jug? Contact Republic Services at (916) 725-9060 and they will deliver one out to you!



Don't Get Stuck with Sharps!

Used household sharps must be disposed of properly by placing them in approved sharps containers. This is for the safety of those who must handle these materials after disposal. Approved sharps containers are widely available at local drug stores, pharmacies, and the Republic Services'



Transfer Station. Republic Services provides FREE, front-door collection of home generated hypodermic needles, syringes and lancets by appointment. Sharps containers must be closed and locked and picked up at your doorstep. To make an appointment for free pick up, contact Republic Services at (916) 725-9060 or (916) 638-9000.

Curbside Collection



Curbside Battery Collection: Do you have used or expired single-use or rechargeable batteries? These household batteries can be recycled by placing them inside a sealed quart sized plastic storage bag (such as Ziploc) and setting the bag on top of your mixed recycling cart for collection during recycling collection weeks.



Household Batteries Include:

- Dry Cell
- Rechargeable
- Alkaline
- Lithium (small button shaped battery MUST be taped at both ends to prevent a fire/explosion)

SCHOOL ZONE TRAFFIC LAWS

The Citrus Heights Police Department would like to remind all students and parents of the shared responsibility they have in understanding and obeying traffic laws that help maintain safety in and around our school zones. For this purpose, we have provided a list of the most commonly violated traffic laws in our City's school zones, allowing you to make a conscious and informed effort to create a safe environment for your fellow students, and or your children.

PARKING LAWS

California Vehicle Code section 21458(a) describes rules for curb markings.

- 1. RED Curb indicates no stopping, standing, or parking, whether the vehicle is attended or unattended, (No Student Drop Off or Pick Up in Red Zones)
- 2. YELLOW Curb indicates stopping for the loading or unloading of passengers or freight (20 Minutes For Material & 3 Minutes For Passengers)
- 3. WHITE Curb indicates stopping for the loading or unloading of passengers (3 Minutes for Passengers)
- 4. GREEN Curb indicates time limit parking specified by local ordinance (24 & 30 Minute Zones)
- 5. BLUE Curb indicates parking limited exclusively to the vehicles of disabled persons

V.C. 22500(H) DOUBLE PARKING

Prohibits stopping, parking, or standing of any attended/unattended vehicle on the roadway side of any vehicle stopped, parked or standing at the curb or edge of a highway (Often seen as parents drop off/pick up children in the lanes of traffic)

V.C. 22500(b) Park in Cross Walk

Prohibits the stopping, parking, or standing of any attended/unattended vehicle in a crosswalk

V.C. 22500(e) Park in Front of Public Drive

Prohibits stopping, parking, or standing of any attended/unattended vehicle in front of a public driveway

V.C.22SOO(i) BusZone

Prohibits stopping, parking, or standing of any attended/unattended vehicle alongside a curb authorized for the loading and unloading of passengers of a bus, when indicated by a sign or red paint on the curb.

V.C. 22502 Parking Over 18" from Right Hand Side of Curb / Parking on Wrong Side of Street

Every vehicle *stopped* or *parked* upon a roadway...shall be stopped or parked with the right hand wheels of such vehicle *parallel* with and within 18 inches of the right-hand curb, except that motorcycles shall be parked with at least one wheel or fender. touching the right-hand curb.

V.C. 22514 Park Near Fire Hydrant

No person *shall stop, park, or leave standing* any vehicle within 15 feet of a fire hydrant. EXCEPT, If the vehicle is attended by a licensed driver who is seated in the front seat and who can *immediately move* such vehicle in case of necessity. <u>Side</u>Note-If the curb next to the fire hydrant is painted red, the vehicle stopping or parking to facilitate student pickup or drop off could still be cited for stopping/parking in a red zone

Enforcement

It is important to remember that the registered owner is the person receiving the citation, not the driver of the vehicle. The registered owner is responsible to resolve the citation. If parking citations are not cleared, either by dismissal or payment, the registered owner may not be able to renew their vehicle's registration until the citation has been cleared by the DMV. Vehicles that have five or more citations on file are subject to impound, per California Vehicle Code section 22651(i)(I). The enforcement of parking restrictions and traffic laws in our school zones helps maintain vehicle and pedestrian safety, reminds drivers and pedestrians of their responsibility to share the roadway, and hopefully serves as a deterrent to prevent persons from future rule breaking.

SCHOOL ZONE TRAFFIC LAWS CONTINUED

MOVING & NON-MOVING VIOLATIONS



V.C. 22101(d) Disobey Traffic Control Devices (No *Left Turn, No Turn on Red, Yield, or No U-turn Signs at an Intersection*) When official traffic control devices are placed as required in subdivision (b) or (c), it shall be unlawful for any driver of a vehicle to disobey the directions of such official traffic control devices

V.C

V.C. 21461(a) Failure to Obey a Posted Sign (No *left turn, No U-Turn, No Student Drop Of/Signs,* etc) It is unlawful for a driver of a vehicle to fail to obey a sign or signal, or to fail to obey a device erected or maintained by lawful authority of a public body or official.

V.C. 22103 No U-turn in Residential District

No person in a residential district shall make a U-turn when any other vehicle is approaching from either direction within 200 feet, *except* at an intersection when the approaching vehicle is controlled by an official traffic control-device.



V.C. 21950(a) Drivers Yield to Pedestrians in Cross Walk

The driver of a vehicle shall yield the right of way to a pedestrian crossing the roadway within any marked crosswalk or within any unmarked crosswalk at an intersection.



V.C. 21950(b) Pedestrian to Exercise Due Care

This section does not relieve a pedestrian from the duty of using due care for his or her safety. No pedestrian may suddenly leave a curb or other place of safety and walk or run into the path of a vehicle that is so close as to constitute an immediate hazard. No pedestrian may unnecessarily stop or delay traffic while in a marked or unmarked crosswalk.

V.C. 21950(c) Drivers to Exercise Due Care

The driver of a vehicle approaching a pedestrian within any marked or unmarked crosswalk shall exercise all due care and shall reduce the speed of the vehicle or take any other action relating to the operation of the vehicle as necessary to safeguard the safety of pedestrians.

V.C. 21954(a) Pedestrians Outside Of Crosswalks

Every pedestrian upon a roadway at any point other than within a marked crosswalk or within an unmarked crosswalk at an intersection shall yield the right of way to all vehicles upon the roadway so near as to constitute an immediate hazard.



Pedestrians shall not cross the roadway at any place except in a crosswalk between adjacent intersections controlled by traffic control signal devices or by police officers.

V.C. 21100.3 Disobey a Crossing Guard

It is unlawful for any person to disobey the traffic directions of a person appointed or authorized by local authority to regulate traffic pursuant to subdivision (e) of Section 21000 when such appointee is wearing an official insignia issued by the local authority and is acting in the course of his appointed duties.





V.C. 22350 Unsafe Speed (School Zone)

When signs are posted for a "School Zone-When Children Present", the speed limit is reduced to 25 MPH. This applies whenever children are present (Before, During & After School).

V.C. 23123(a) Talking on Cell Phone While Driving (18 +=Adult) & V.C. 23124 Cell Phone Under 18 Yrs.

Adult shall not drive a vehicle while using a wireless telephone, unless hands free. Minors may not use cell or hands free device.



V.C. 23123.5 Texting While Driving

A person shall not drive a motor vehicle while using an electronic wireless communication device to write, send or read texts.

H&S 118948(a) Smoking in Vehicle

It is unlawful for a person to smoke a pipe, cigar, or cigarette in a motor vehicle, whether in motion or at rest, in which there is a minor (someone under 18 years old). For the purpose of this section, "To *smoke*" means to have in one's immediate possession a *lighted pipe, cigar, or cigarette containing tobacco or any other plant.*

Seatbelt Laws

The driver and all occupants of a moving vehicle must properly wear safety belts, as they were designed to be worn. The shoulder strap must be worn over shoulders, not under.



V.C. 21212(a) Helmet Laws

Persons under 18 years of age must wear a properly fitted and fastened helmet for bicycles, skateboards, roller blades, etc.

Yield to Emergency Vehicles – Pull Over to the Right

You must yield the right-of-way to any police vehicle, fire engine, ambulance, or other emergency vehicle using a siren and red lights. Drive to the right edge of the road and stop until the emergency vehicle(s) have passed. However, never stop in an intersection. If you are in an intersection when you see an emergency vehicle, continue through the intersection and then, drive to the right as soon as it is safe and stop. Emergency vehicles often use the wrong side of the street to continue on their way. They sometimes use a loud speaker to talk to drivers blocking their path.

You must obey any traffic direction, order, or signal given by a firefighter, traffic or police officer, even if it conflicts with existing signs, signals, or laws.

It is against the law to follow within 300 feet behind any fire engine, police vehicle, ambulance, or other emergency vehicle with a siren or flashing lights (CVC §21706).


If you drive for sight-seeing purposes to the scene of a fire, collision, or other disaster, you may be arrested. Casual observers interfere with the essential services of police, firefighter, ambulance crews, or other rescue or emergency personnel.

The above information is from the California Department of Motor Vehicles, California Driver Handbook. Metro Fire recommends the following:

If you do not see an emergency vehicle, but see cars pulling over to the right side of the road, slow down. You should check mirrors and look ahead to see if there are emergency vehicles with flashing lights. You may need to pull over too. Slowing down will also allow drivers who are pulled over to reenter the roadway after emergency vehicles are 300 feet ahead. It is unlawful to follow within 300 feet of an emergency vehicle when sirens sound and lights are flashing.




