## 2023 and 2024 Homeless Count Comparison

- The chart below is a 2023 and 2024 Homeless Count comparison of the categories which were reported in both years.

## Homeless Individuals Identified<sup>i</sup>

- 108 individuals were identified as homeless.
- 14 of the 108 homeless individuals had no previous contact with CHPD (13%).

## Previous Arrests and Trespassing Notices Issued by CHPD<sup>ii</sup>

- 64 of the 108 homeless individuals had been arrested by CHPD (59%).
- 50 of the 108 homeless individuals had been issued trespassing notices by CHPD (46%).

## Arrests and Trespassing Notices Issued between January 1, 2023 – March 15, 2024<sup>iii</sup>

- 34 of the 108 homeless individuals were arrested by CHPD between the dates of January 1, 2023 – March 15, 2024 (31%).
- 37 of the 108 homeless individuals were issued trespassing notices by CHPD between the dates of January 1, 2023 – March 15, 2024 (34%).

## Previous Arrests for Narcotics Related Crimes and Violent Crimes<sup>iv</sup>

- 58 of the 108 homeless individuals had previously been arrested for narcotics related crimes (54%).
- 34 of the 108 homeless individuals had previously been arrested for violent crimes (31%).

## Probation Status<sup>v</sup>

- 10 of the 108 homeless individuals are currently on a probationary status (9%).

**Homeless Individuals that are from or have lived in Citrus Heights<sup>vi</sup>**

- 57 of the 108 homeless individuals stated they were from or have lived in Citrus Heights (53%).

**Mental Health Issues<sup>vii</sup>**

- 22 of the 108 homeless individuals admitted to having a mental health illness (20%).

**Alcohol or Drug Dependency<sup>viii</sup>**

- 55 of the 108 homeless individuals admitted to having an alcohol and/or drug dependency (51%).

**Homeless willing to work with a Homeless Navigator<sup>ix</sup>**

- 79 of the 108 homeless individuals provided consent to forward their information to a homeless navigator (73%).
